After a phone conversation with the family, Jane took the lead and organized the details of every appointment for the father and son, she explained to the family what the appointments were for and she assisted with securing transportation for the son to and from his appointments.

NVCH sees this as an incredible service to the communities we serve. Jane does a phenomenal job at ensuring that our patients and their families have the benefit of a resource to assist, as needed, in helping coordinate their care among multiple health care facilities and providers.



## Increasing and Improving Access to Care NVCH Expansion and Remodel Project

Progress continues with our expansion and remodel project! These improvements will strengthen our capabilities and provide the infrastructure necessary to continue the level of service and quality of care vital for our rural hospital. There will always be change in the world of healthcare and adapting to that constant change is essential for us to continue to provide the level of service and high quality of care our patients and their families deserve. This is an essential investment in our healthcare team, the success of our organization, and the continued growth of our community.

The design will integrate new technology, create an environment that improves the patient experience and efficiency for staff, and ensure a sustainable future for health care in our area. Additions and upgrades to critical improvement areas throughout the facility include:

 New nursing wing with 14 patient rooms, private family room and direct access to the Emergency Department.

- Expanding and upgrading the Emergency Department to meet the needs of today's technology in addition to privacy and security requirements. Critical 'safe' areas are also being created for staff, patients, and visitors.
- Enhancing the surgical and radiology departments to meet regulatory and equipment standards.
- New services including Oncology and Pulmonary Rehabilitation.
- Updating mechanical systems facility wide. The air handling units, medical air system, boilers and hot water heaters, and our electrical system have all outlived their life expectancy and are not suitable for meeting regulatory demands.

These enhancements ensure that our patients can stay close to home when seeking the best medical care available. We are always looking for ways to improve the patient experience while delivering the highest quality of care possible.

This new design will help centralize patient care as well as enhance patient safety, privacy and comfort—all very important when it comes to delivering first-rate nursing and emergency care service.



# Our Impact

Every year, in accordance with government requirements as a non-profit critical access hospital, we prepare a community benefit report to define our financial benefits for the community. But, NVCH's efforts expand far beyond quantifiable financial benefits. According to the Kansas Hospital Association's The Importance of the Health Care Sector to the Nemaha County Economy 2023 Report, the health care sector in Nemaha County generates significant employment and income for local residents and generous tax revenue for local governments. Health care businesses in Nemaha County provide about 897 jobs and nearly \$42.7 million in labor income and supports an estimated \$351,700 in local sales tax revenue.

## Community Health Needs Assessment

Every three years Nemaha Valley Community Hospital (NVCH) partners with Sabetha Community Hospital (SCH) to identify and prioritize the greatest health needs for the communities we serve. This comprehensive process is our Community Health Needs Assessment (CHNA).

We recognize the health needs of patients coming through our doors may not represent the wider health needs of our communities. Therefore, we collaborate with area stakeholders and leaders throughout our communities to analyze and identify gaps and priorities within our communities. We then take that information and establish a three-year implementation plan to guide us through developing action items that will have the greatest impact on the communities we serve.

Consistent themes from previous years continue to emerge including access to mental health needs, health education and cancer care.

Since our 2020 assessment, we have worked endlessly to address significant health needs of the communities we serve to maximize our resources and access in response to those needs. Mental Health: NVCH regularly provides mental health education to the staff of NVCH and the public. We recently added Behavioral Health Therapy tele-health service in our rural health clinic, Seneca Family Practice. We also continue to update mental health screenings and placement procedures, resources and contacts in the emergency room and other necessary areas of the hospital.

Health Education: NVCH regularly provides health and wellness education to the public through in-person presentations, social media, print media and radio ads. We also maintain communication with current and potential Industrial Wellness businesses by offering various health and wellness opportunities at the workplace.

**Cancer Care**: NVCH has made great strides in Cancer Care collaboration, education and community outreach in our community and surrounding communities. We are offering dermatology services, early detection screenings and oncology services are coming soon!
