

Community Health Education and Outreach:

In 2023-2024 more than 100 Nemaha Valley Community Hospital (NVCH) employees gave their time and talents to area non-profits and other organizations. Over 50 area organizations have received assistance, and over **4,000** volunteer services hours have been given by NVCH employees and our Volunteer Services Program.

Employees spent their hospital outreach time educating area residents on topics such as Stop the Bleed & CPR/AED, Fall Prevention, Diabetes Education, Preventative Care and other healthcare related topics. Their volunteer hours were also served through area churches, schools, 4-H clubs, Legions, blood drives, making mats for the homeless and other community events.

Improving Patient Safety & Access to Care

Equipment management is a critical aspect of hospital operations that directly impacts patient care quality, staff efficiency, and financial performance. Nemaha Valley Community Hospital relies on a wide range of medical devices and equipment to diagnose, treat, and monitor patients. From imaging machines and surgical instruments to patient monitors and infusion pumps, we must ensure that their equipment is up-to-date, well-maintained, and functioning properly to deliver optimal care our friends and family deserve.

The quality of medical equipment directly affects patient outcomes, as it plays a crucial role in diagnosing conditions, monitoring vital signs, and delivering treatments. Investing in our hospitals has kept Nemaha County near the top of the Kansas County Health Rankings for the last several years and ensures that our residents don't need to travel for excellent healthcare services.



- Upcoming and included in our construction and remodel project - On-site MRI unit. MRI is one of the most commonly used imaging techniques in modern medicine. The unit offers shorter scan times for patients, higher image quality to support diagnostic accuracy, and a larger opening than our mobile unit to help claustrophobic patients.
- Pyxis MedStation: The MedStation is an automated medication dispensing system supporting decentralized medication management. It helps our staff safely and efficiently dispense the right medications, for the right patients at the right time.
- Facility wide and included in our construction and remodel project - Upgrade to Mechanical Systems: The air handling units, medical air system, boilers and hot water heaters, and our electrical system have all outlived their life expectancy and are not suitable for meeting regulatory demands.









Community Benefit Priorities

To help Nemaha Valley Community Hospital (NVCH) improve health through outreach, prevention, education, and wellness efforts, we conduct Community Health Needs Assessments (CHNA) every three years. We work with a wide range of community partners to help identify and prioritize the greatest health care needs in the communities we serve.

NVCH develops a CHNA Implementation Plan based on the data and results of CHNA of the communities we serve. The Implementation Plan serves as a strategy for meeting the identified needs of our communities and includes goals and objectives for implementing these community benefits.

Mental Health: NVCH regularly provides mental health education to the staff of NVCH and the public. We continue to offer youth and adult Behavioral Health Therapy tele-health service in our rural health clinic, Seneca Family Practice. We also continue to update mental health screenings and placement procedures, resources and contacts in the emergency room and other necessary areas of the hospital.

Chronic Disease Management: NVCH is proud to offer care coordination which helps monitor and coordinate patients' treatment plans, provides education about their condition, connects them with health care providers, and evaluates their progress. The goal of a care coordinator is to ensure that patients have the


benefit of a resource to assist, as needed, in helping coordinate their care among multiple health care facilities and providers.

Youth Health Education: NVCH recognizes that youth health education is essential for empowering young people to make healthy choices, develop essential life skills, and build a strong foundation for lifelong well-being. We have partnered with area schools to provide accurate information to our youth about the importance of mental health awareness and resilience, balanced nutrition, the benefits of regular exercise and the risks associated with unhealthy behaviors such as vaping, alcohol, and drug use.

Our Impact

Every year, in accordance with government requirements as a non-profit critical access hospital, we prepare a community benefit report to define our financial benefits for the community. But, NVCH's efforts expand far beyond quantifiable financial benefits. This report highlights the countless ways our team - physicians, nurses, administration, ancillary staff, volunteers and beyond - fulfill our purpose to make a positive difference in every life and every community we touch.

According to the Kansas Hospital Association's The Importance of the Health Care Sector to the Nemaha County Economy 2023 Report, the health care sector in Nemaha County generates significant employment and income for local residents and generous tax revenue for local governments. Health care businesses in Nemaha County provide about 897 jobs and nearly \$42.7 million in labor income and supports an estimated \$351,700 in local sales tax revenue.
